## ***EPA Cuts are Bad News for Radon Community & Homeowners***



Last month, AARST urged all members to contact their state representatives to object to the proposed elimination of the EPA Radon Program from the 2018 federal budget, providing key talking points to help members communicate the serious implications of a country without funding for a Radon Program.

Not only would this be bad news for homeowners everywhere, those relying on grant money for crucial initiatives, and people who do essential work in radon offices across the country, but a \$0 radon budget is bad news for YOU and your business.

Those of us in the radon industry already know the struggle of trying to communicate to homeowners and others the serious risks of radon. Without a federal program, homeowners will now have more of a reason to further doubt the radon message.
